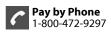

Subject: Chief's Report

General

In general, everything within the District has been going well.

Agreement for the Volunteer Fire Capacity Program of the Cooperative Forestry Assistance Act of 1978

THIS AGREEMENT, made and entered be	tween the STATE of California, acting through the
	Fire Protection hereinafter called "STATE", and
Pajaro Valley Fire Protection District	hereinafter called "LOCAL AGENCY",
covenants as follows:	

RECITALS:

- 1. STATE has been approved as a passthrough agent of the United States Department of Agriculture, (USDA), Forest Service for the purpose of administering the Volunteer Fire Capacity program in California, hereinafter referred to as VFC, authorized by the Cooperative Forestry Assistance Act (CFAA) of 1978 (PL 95-313, 92 Stat 365, 16 U.S.C. 2106), as amended.
- 2. This is a subaward under the FY2025 State of California Volunteer Fire Capacity Projects Grant #25-DG-11052012-154 awarded to STATE by the Forest Service on September 20, 2025. The Federal Assistance Listing for the award is 10.698, Cooperative Fire Program. This subaward is funded solely with Federal funds and is subject to the Office of Management and Budget (OMB) guidance in subparts A through F of 2 CFR Part 200, as adopted and supplemented by the USDA in 2 CFR Part 400, and under certain terms and conditions to LOCAL AGENCY to assist LOCAL AGENCY to upgrade its fire protection capability.
- 3. LOCAL AGENCY desires to participate in said VFC and agrees to the terms and conditions specified in the Procedural Guide for Volunteer Fire Capacity Program 2025.

NOW THEREFORE, it is mutually agreed between the parties as follows:

- 4. <u>APPROVAL</u>: This Agreement is of no force or effect until signed by both parties and approved by the Department of General Services, if required. LOCAL AGENCY may not commence performance until such approval has been obtained.
- 5. <u>INCORPORATION</u>: The Procedural Guide for Volunteer Fire Capacity Program 2025, submitted Application for Funding and associated Grant Assurances are hereby incorporated by reference as part of the Grant Agreement.
- 6. TIMELINESS: Time is of the essence in this Agreement.
- 7. FORFEITURE OF AWARD: LOCAL AGENCY must return this Agreement and required resolution properly signed and executed to STATE at the email address specified in paragraph 12, with a timestamp no later than January 31, 2026 or LOCAL AGENCY will forfeit the funds.

8. GRANT AND BUDGET CONTIGENCY CLAUSE: It is mutually understood between the parties that this **Agreement** may have been written for the mutual benefit of both parties before ascertaining the availability of congressional appropriation of funds, to avoid program and fiscal delays that would occur if the **Agreement** were executed after that determination was made.

This **Agreement** is valid and enforceable only if sufficient funds are made available to the STATE by the United States Government for the **State Fiscal Year 2025** for the purpose of this program. In addition, this **Agreement** is subject to any additional restrictions, limitations, or conditions enacted by the Congress or to any statute enacted by the Congress that may affect the provisions, terms, or funding of this **Agreement** in any manner.

The parties mutually agree that if the Congress does not appropriate sufficient funds for the program, this **Agreement** shall be amended to reflect any reduction in funds.

The STATE has the option to invalidate the **Agreement** under the 30-day cancellation clause or to amend the **Agreement** to reflect any reduction in funds.

- 9. REIMBURSEMENT: STATE will reimburse LOCAL AGENCY, from funds made available to STATE by the Federal Government, an amount not to exceed \$10,318.35 on a 50/50 matching funds basis, for the performance of specific projects and/or purchase of specific items identified in Proposed Project, Application for Funding, attached hereto.

 Reimbursement will be only for those projects accomplished and/or items purchased between THE LAST SIGNATORY DATE ON PAGE 1 and AUGUST 31, 2026. This sum is the sole and maximum payment that STATE will make pursuant to this Agreement.

 LOCAL AGENCY must bill STATE at the e-mail address specified in paragraph 12, with a timestamp no later than NOVEMBER 1, 2026 in order to receive the funds. The bill submitted by LOCAL AGENCY must clearly delineate the projects performed and/or items purchased. A vendor's invoice and proof of payment to vendor(s) must be included for items purchased.
- 10. <u>LIMITATIONS</u>: LOCAL AGENCY shall notify STATE prior to purchase of any Equipment as defined under 2 CFR 200.1 "Equipment." Expenditure of the funds distributed by STATE herein is subject to the same limitations as placed by the VFC, upon expenditure of United States Government Funds. Pursuant to 2 CFR 200.313 Equipment, subject to the obligations and conditions set forth in that section; title to any equipment and supplies acquired under this **Agreement** vests with the LOCAL AGENCY. For any equipment items over \$10,000, the federal government may retain a vested interest in accordance with paragraph 17 below.
- 11. MATCHING FUNDS: Any and all funds paid to LOCAL AGENCY under the terms of this **Agreement**, hereinafter referred to as "VFC Funds", shall be matched by LOCAL AGENCY on a dollar-for-dollar basis, for each project listed on attachment(s) hereto identified as "Proposed Project". No amount of unpaid "contributed" or "volunteer" labor or services shall be used or consigned in calculating the matching amount "actually spent" by LOCAL AGENCY.

LOCAL AGENCY shall not use VFC Funds as matching funds for other federal grants, including Department of Interior (USDI) Rural Fire Assistance grants, nor use funds from other federal grants, including USDI Rural Fire Assistance grants, as matching funds for VFC Funds.

- 13. <u>PURPOSE</u>: Any project to be funded hereunder must be intended to specifically assist LOCAL AGENCY to organize, train, and/or equip local firefighting forces in the aforementioned rural area and community to prevent or suppress fires which threaten life, resources, and/or improvements within the area of operation of LOCAL AGENCY. Project funds are not to be used for research and development.
- 14. <u>COMBINING</u>: In the event funds are paid for two or more separate, but closely related projects, the 50/50 cost-sharing formula will be applied to the total cost of such combined projects.
- 15. <u>OVERRUNS</u>: In the event that the total cost of a funded project exceeds the estimate of costs upon which this Agreement is made, LOCAL AGENCY may request additional funds to cover the **Agreement** share of the amount exceeded. However, there is no assurance that any such funds are, or may be, available for reimbursement. Any increase in funding will require an amendment.
- 16. <u>UNDERRUNS</u>: In the event that the total cost of a funded project is less than the estimate of costs upon which this **Agreement** is made, LOCAL AGENCY may request that additional eligible projects/items be approved by STATE for **Agreement** funding. However, there is no assurance that any such approval will be funded. Approval of additional projects/items, not listed on the Proposed Project application, made by STATE, will be in writing and will require an amendment.
- 17. FEDERAL INTEREST IN EQUIPMENT: Items of equipment with a current fair market value in excess of \$10,000 (per-unit) may be retained or sold by LOCAL AGENCY once it is no longer needed for the original project, program, or for other activities supported by the awarding Federal agency. However, the Federal agency is entitled to an amount calculated by multiplying the percentage of the Federal agency's contribution towards the original purchase by the current market value or proceeds from the sale. If the equipment is sold, the STATE may permit the LOCAL AGENCY to retain, from the Federal share, \$1,000 of the proceeds to cover expenses associated with the selling and handling of the equipment. LOCAL AGENCY will notify STATE of the disposal of such items.

18. <u>EQUIPMENT INVENTORY</u>: Any single item purchased in excess of \$10,000 will be assigned a VFC Property Number by the STATE. LOCAL AGENCY shall forward a copy of the purchase documents listing the item, brand, model, serial number, any LOCAL AGENCY property number assigned, and a LOCAL AGENCY contact and return address to STATE at the address specified in paragraph 12. The STATE will advise the LOCAL AGENCY Contact of the VFC Property Number assigned.

- 19. <u>AUDIT</u>: LOCAL AGENCY agrees that the STATE, the Department of General Services, the California State Auditor, or their designated representative shall have the right to review and to copy any records and supporting documentation pertaining to the performance of this **Agreement**. LOCAL AGENCY agrees to maintain such records for possible audit for a minimum of five (5) years after final payment, unless a longer period of records retention is stipulated. LOCAL AGENCY agrees to allow the auditor(s) access to such records during normal business hours and to allow interviews of any employees who might reasonably have information related to such records. Further, LOCAL AGENCY agrees to include a similar right of the State of California to audit records and interview staff in any subcontract related to performance of this **Agreement**. (GC 8546.7, PCC 10115 et seq., CCR Title 2, Section 1896).
- 20. <u>DISPUTES</u>: In the event of any dispute over qualifying matching expenditures of LOCAL AGENCY or audit findings, the dispute will be decided by STATE and its decision shall be final and binding.
- 21. <u>MONITORING</u>: LOCAL AGENCY agrees to the monitoring of activities as necessary by STATE to ensure that the award is used for authorized purposes, in compliance with Federal statutes, regulations, and the terms and conditions of the agreement; and that performance goals are achieved.
- 22. <u>INDEMNIFICATION</u>: LOCAL AGENCY agrees to indemnify, defend, and save harmless, the STATE, its officers, agents, and employees, from any and all claims and losses, accruing or resulting to any and all contractors, subcontractors, suppliers, laborers, and any other person, firm or corporation furnishing or supplying work services, materials, or supplies in connection with the performance of this **Agreement**, and from any and all claims and losses accruing or resulting to any person, firm or corporation who may be injured or damaged by LOCAL AGENCY in the performance of this **Agreement**.
- 23. <u>CIVIL RIGHTS</u>: LOCAL AGENCY agrees to comply with civil rights requirements as detailed in the Complying With Civil Rights Requirements brochure (FS-850) and the And Justice For All poster (AD-475A). The poster is to be placed at all public points of contact/reception areas.
- 24. <u>DRUG-FREE WORKPLACE REQUIREMENTS</u>: LOCAL AGENCY will comply with the requirements of the Drug-Free Workplace Act of 1990 and will provide a drug-free workplace by taking the following actions:
 - a. Publish a statement notifying employees that unlawful manufacture, distribution, dispensation, possession or use of a controlled substance is prohibited and specifying actions to be taken against employees for violations.

- b. Establish a Drug-Free Awareness Program to inform employees about:
 - 1) the dangers of drug abuse in the workplace;
 - 2) the person's or organization's policy of maintaining a drug-free workplace;
 - 3) any available counseling, rehabilitation and employee assistance programs; and,
 - 4) penalties that may be imposed upon employees for drug abuse violations
- c. Every employee who works on the proposed **Agreement** will:
 - 1) receive a copy of the company's drug-free workplace policy statement; and.
 - 2) agree to abide by the terms of the company's statement as a condition of employment on the **Agreement**.

Failure to comply with these requirements may result in suspension of payments under the **Agreement** or termination of the **Agreement** or both and LOCAL AGENCY may be ineligible for funding of any future State **Agreement** if the department determines that any of the following has occurred: (1) the LOCAL AGENCY has made false certification, or violated the certification by failing to carry out the requirements as noted above. (GC 8350 et seq.)

- 25. <u>TERM</u>: The term of the Agreement SHALL COMMENCE ON THE LAST SIGNATORY DATE ON PAGE 1 and continue through August 31, 2026.
- 26. <u>TERMINATION</u>: This **Agreement** may be terminated by either party giving 30 days written notice to the other party or provisions herein amended upon mutual consent of the parties hereto.
- 27. <u>AMENDMENTS</u>: No amendment or variation of the terms of this **Agreement** shall be valid unless made in writing, signed by the parties and approved as required. No oral understanding or **Agreement** not incorporated in the **Agreement** is binding on any of the parties.
- 28. <u>INDEPENDENT CONTRACTOR</u>: LOCAL AGENCY, and the agents and employees of LOCAL AGENCY, in the performance of this **Agreement**, shall act in an independent capacity and not as officers or employees or agents of the STATE or the Federal Government.
- 29. <u>INDIRECT RATE</u>: LOCAL AGENCY may not assess an indirect rate in excess of their Federally approved Negotiated Indirect Cost Rate Agreement (NICRA) or a de minimis rate if LOCAL AGENCY does not have an approved NICRA, not to exceed 15%. LOCAL AGENCY may also elect not to assess an indirect rate. The approved indirect cost rate at the time of execution is 0%.

- 30. <u>MEDIA</u>: LOCAL AGENCY shall acknowledge STATE and USDA Forest Service support in any publications, audiovisuals and electronic media developed as a result of this award.
 - It is encouraged to give public notice of the receipt of this award and announce progress and accomplishments, acknowledging STATE and USDA Forest Service support. Follow direction in USDA Supplemental 2 CFR 415.2.
- 31. <u>ASSIGNMENT</u>: This Agreement is not assignable by LOCAL AGENCY either in whole or in part.

Dear Board Members,

On August 31, 2015, a fire occurred at the Parkfield Battery Storage System, part of the California Flats Solar Project. This incident was "successful" because the containment systems worked as planned and no lives were lost. Yet, even in this best case scenario:

2-4 Tesla Megapack Modules burned for hours. They were part of one 20MWh Tesla Megablock.

A 2 mile evacuation order was issued. Thankfully on 18 people lived in this 2 mile zone.

Unknown quantities of water were required to cool adjacent Megapacks. Gas and smoke plumes were unreported, leaving unanswered questions about exposure.

If we superimpose this incident on the proposed Minto Road BESS facility or the Freedom High School or Dominican Hospital proposed BESS sites the impact would be significant.

We should not have a Grid Scale BESS Facility near any sensitive receptors in Santa Cruz County. Assemblymember Dawn Addis has a bill, AB 303, still in committee, that proposes a 3200 foot setback for BESS facilities over 200 MWh. This would create a loophole for facilities just under this limit. I ask that you recommend Santa Cruz adopt a scaled setback approach. For example:

Facility Size (MWh)

Proposed Setback

From Sensitive Receptor

10-49

300ft

50-199

600ft

200+

1,200ft

This framework closes the loophole for sub-200MWh projects,

And provides predictable, proportional safety buffers. I urge the Fire District to recommend that Santa Cruz County incorporate scaled setbacks into its BESS ordinance. This approach ensures that all residents, regardless of project size, receive meaningful protection from fire, smoke, and evacuation risks.

Dear Chief Wilson and Deputy Fire Marshal Walters,

Last night, Santa Cruz County Planning staff announced to the County's Commission on the Environment that the Board of Supervisors is now moving quickly to review a Draft BESS Ordinance for the County.

The matter could come before the Supervisors within the next few weeks.

This is being pressured by the Seahawk Energy Project developer, New Leaf Energy and Sequoia Energy, at 90 Minto Road, Watsonville.

I have reviewed Public Records Act request documents that show the project's developer and consultants are strongly resisting a full Environmental Impact Report (EIR), while making their own interpretations of County Codes, definitions, and ag land use determination. I am concerned that the Board of Supervisors could adopt less-protective measures for this grid-scale lithium ion BESS facility, at the risk of compromising safety of responding firefighters, the public, livestock, wildlife and the agricultural resources nearby, including College Lake.

For that reason, I hereby ask that the Pajaro Valley Fire Protection District Board form an Ad Hoc Committee that includes the Fire Marshal to study and develop District-based Fire Codes that will provide a better level of public health and safety protection than current Codes include.

On August 19, 2025, the Board of Supervisors voted to postpone review of the "in concept" County BESS Ordinance until August, 2026.

Many feel that this delay could cause potential grid-scale BESS developers to apply to the California Energy Commission (CEC) for an Opt-In Certificate of operation, as allowed under AB 205, and by-pass local jurisdiction review. However, the local fire jurisdictions would still have authority to review the project applications and issue approvals.

It seems that the Board of Supervisors is being pressured to now move more quickly.

Therefore, it is incumbent that you study this issue and take action to set in place codes within Pajaro Valley Fire Protection District that could be *more protective* than what current State Fire Codes currently allow. As you know, those State Fire Codes regarding BESS are in the process of update, but will not be in effect until July 1, 2027.

Under Fire Code Section 1.1.7.3, when there are conflicts in code requirements, the more strict code applies.

I respectfully request that your Board form an Ad Hoc Committee for the purpose of studying the following sections of the Fire Code, and develop a more protective set of lithium ion battery energy storage system (BESS) fire codes, and adopt them in a timely manner:

1.11.2.3 Administrative Scope

Chapter 1 Part 1 Section 101
101.2 Fire and Explosion
Section 105
105.5.16 Explosions
105.5.14 Energy Storage Systems
105.5.53 Lithium Batteries (and section 322.1)
105.6.5 Energy Storage Systems and section 1207
105.6.6 Fire Alarm and detection systems and related equipment
(A) 105.6.10 Gas Detection systems

Section 109 Testing and Inspection (A) 109.2 109.3 109.4

(A) 105.6.12 Hazardous Materials

I also request that the Ad Hoc Committee and Fire Marshal apply all Hazards Materials Regulations relating to transport of lithium ion batteries into and out of the District, as well as decommissioning plans: https://www.phmsa.dot.gov/sites/phmsa.dot.gov/files/2024-11/Lithium-Battery-Guide-2024.pdf

Finally, I want to provide you with some information that you may find useful:

1) Since the District Board could consider adopting stronger, more protective requirements for BESS Projects you may want to be aware of the following information and craft a requirement for additional testing of any and all alarm notification equipment.

E. Battery Energy Storage Systems (BESS) for early fire detection (Chief Crystal Sujeski) Chief Crystal Sujeski informed the committee that CFC, 2025 Edition, Chapter 1207 will be the main section for Energy Storage Systems and will be monitoring what's going in the IFC 2027 Edition. Guest Joseph Cervantes informed the committee that there are container units that are being shipped in have pre-installed fire alarm equipment that is being installed by a non-licensed integrator or installer and a lot of the systems installed are not listed. Member James Carver brought up the fact that, in his experience, he has seen many of these containers have passed the warranty period just from sitting on ships for years. Member David Myers attested to the previous comments, and added, that he has encountered over 50 percent failure rate when inspecting these containers.

2) PLEASE CONSIDER A MORATORIUM ON LITHIUM BESS FACILITIES, due to unacceptable fire and off-gas risks to your firefighters and the public.

Yesterday's Lithium BESS Fire in Boulder City, Nevada occurred in the same type of modules and lithium battery chemistry as what is proposed for the 90 Minto Road Seahawk Energy Storage Facility:

That Chief stated the mitigation effort to cool other nearby battery modules required sustained pressurized water delivery of 1200-1500 gal/minute for hours, until the fire burned itself out. How would such large water demands affect the neighboring subdivision water supply and fire suppression ability if another fire began nearby?

How would this significant amount of contaminated runoff be stored or prevented from flowing into College Lake?

3) Please consider requiring the developer to provide drone technology to the Fire Department, along with training and certification, for use in site assessment when a battery unit begins to offgas or exhibit thermal runaway. This is critical to protect first responder safety, as the Project Risk Assessment Report states that responders should NOT approach closer than 100', due to the real possibility of explosions and the metal container doors becoming projectiles.

4) The Seahawk Energy Project Risk Assessment report states that no personnel should staff the site, due to off-gassing of carcinogenic compounds. For that reason, the site would be completely monitored and data-driven by electronic systems.

Your District's Ad Hoc Committee could review this information, and consider requiring stronger codes to protect the health and safety of the District's responders and the general public, requiring redundancy and monthly testing of monitoring systems and inherent notifications. Requiring a long-duration fire test and worst-case scenario plume model would help ensure public safety and evacuation planning in a fire and off-gas malfunction.

5) Please consider requiring monthly operational testing of all fire alarm and monitoring systems at a project site that are collaborative with District firefighters and the BESS facility operator/owner.

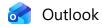
In conclusion, although recent news media report that New Leaf Energy is considering application to the California Energy Commission for Opt-In Certification, due to the delay caused by Santa Cruz County Board of Supervisors approving postponing review of Draft County BESS Ordinance until August, 2026, we now know from County staff that the Board is quickly moving forward. https://lookout.co/battery-storage-developer-aims-to-advance-watsonville-project-before-next-summer-regardless-of-santa-cruz-countys-rules/story

I am aware that the North County Fire Protection District received substantial funding from Vistra related to the permitting of the Moss 300 BESS project. Central Fire Protection District may want to investigate this and the issue of funding the District for adequate staffing and operational response, as well as funding purchase of and operator certification for using drones to surveil reported malfunctions and potential fires and explosions at any proposed BESS site.

Please consider this information, and place the issue on your Board's next agenda.

I'm reaching out on behalf of New Leaf Energy regarding the proposed battery energy storage project near Watsonville. I am the Senior Project Developer responsible for the "Seahawk" project, and would be happy to meet with you to discuss any questions or concerns you may have about the project.

I'm available via phone, virtually or in person. I'm also happy to respond to questions via email.

Concurrently, the County of Santa Cruz is considering an ordinance to regulate the siting and safety of battery energy storage in the County. Supervisor Hernandez's office has scheduled a community meeting on Monday, October 27 (5:30-7:00pm, Watsonville City Council Chambers, 275 Main St., Top Floor). The intent of the meeting is to provide additional information on the County's proposed battery energy storage ordinance in advance of the Board of Supervisors' scheduled vote on the matter on November 18.

In case it is helpful to you, what follows is background and basic information about the project and the ordinance:

New Leaf Energy is proposing the Seahawk battery energy storage facility to be built at 90 Minto Rd., adjacent to the existing PG&E Green Valley Rd. substation. The facility will store clean energy for use during peak electricity demand periods in order to help prevent power shutoffs, reduce harmful air pollution and support the transition to renewable energy.

The project will occupy 14 acres on a 47-acre parcel. The area of the parcel to be developed includes lower quality soil that has been less productive historically. The remaining 33 acres will be placed in a permanent agricultural easement to ensure farming continues.

The Minto Rd. parcel was selected because of its proximity to the existing PG&E substation, which is the only viable site for grid-scale battery storage in Santa Cruz County, and due to the substation's critical grid location for ensuring electricity reliability across the County.

In addition to benefits related to a more stable electricity grid, decarbonization and air quality, the Seahawk project will provide significant local economic benefits including:

- \$41 Million in property tax revenue over 20 years (\$2 Million est. annually) for the County of Santa Cruz, with allocations for schools, libraries, special districts.
- \$8 Million in net sales tax revenue for the County of Santa Cruz from the purchase of equipment.
- \$2 Million contribution to establish a local Community Benefit Fund for public/community projects.

• \$100,000 contribution to the fire protection district for training and specialized equipment.

In terms of safety, the project will meet or exceed the most up to date National Fire Code and California State battery storage requirements. In contrast with older systems that have experienced significant safety issues (such as the January 17 fire at Moss Landing), the Seahawk project will include new modular technology battery units that are housed within purpose-built, sealed containers and meet national fire safety and testing standards.

Each container will be physically separated by a buffer zone of several feet and equipped with on-board monitoring, remote shut-off and specialized fire suppression systems. The batteries will utilize lithium-iron-phosphate (LFP) chemistry, which is far more stable than the nickel-manganese-cobalt (NMC) chemistry found in first-generation systems. LFP is specifically designed for stationary grid applications, whereas the more reactive NMC batteries were developed for electric vehicles.

The project will have a robust Emergency Response Plan developed in coordination with local fire protection agencies. The battery energy storage system will be set back from the property boundary in compliance with national codes and battery testing certifications. This will ensure minimum safe distances for first responders and safe air quality for surrounding areas in the unlikely event of an emergency. The project site will also have a 14-foot tall fire-rated wall around the perimeter. No water runoff will happen during an emergency response because any water used by first responders would be collected in a retention basin, tested, and only released from the property if deemed safe. In addition, no groundwater penetration will be possible because the entire site will be lined with an impermeable barrier.

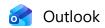

Please share this information.

I am sending this Bcc to many whom I know are concerned about the dangers of grid-scale lithium battery storage projects that the County of Santa Cruz has planned for our neighborhoods, especially the Seahawk Energy facility at 90 Minto Road in Watsonville, where over 300 containers of lithium batteries prone to explosion and toxic fire plumes is already in permitting process with the County.

Tonight, sometime after 6:30pm, the Watsonville City Council will hear a presentation by New Leaf Energy Project leader Mr. Max Christian, about the 90 Minto Road battery energy storage system (BESS) project, in the Green Valley neighborhood area. The City Council Chambers are located at 275 Main Street, Watsonville, on the top floor. Parking in the attached parking garage is free. You can also enter from the Watsonville Library entrance lobby, and take the elevator to the top floor.

The 90 Minto Road Project Presentation is Item 7J:

City Council Meeting - October 14, 2025

This Project is next to many low-income and blue-collar working class neighborhoods, such as Schapiro Knolls, Diamond Estates and the Amador Subdivision. It is next to College Lake (a water source for a new reclamation project), and the Santa Cruz County Fairgrounds (the County's emergency evacuation shelter) is less than one mile away downwind.

We need to fill the Council Chambers and ask that the Council oppose the project. This is what Council member Ari Parker had earlier requested, but staff instead scheduled the presentation by New Leaf to provide the Council with information before taking action to oppose it.

Spanish translation is available.

Please keep in mind that the Watsonville City Mayor, Ms. Maria Orozco, is an analyst for 4th District County Supervisor Felipe Hernandez. He is supporting the New Leaf Project and is pushing the Board of Supervisors to approve a new County Ordinance on November 18 to allow rezoning of agricultural land for the 90 Minto Road project to allow the project to get permit approval.

I have inquired this morning with the City Clerk regarding the possibility of remote participation, but it is unclear at this time whether that will be available or not. There is no remote access information provided on the Council webpage or on the agenda itself.

If you cannot attend the meeting in person tonight, please submit written comment as soon as possible by clicking on the Item 7J line and then the yellow box on the right that will appear with the item materials. At the time of this writing, there are three comments, one of which is mine:

Dear Councilmembers.

If the Seahawk BESS uses lithium batteries, the City of Watsonville will be affected by the hazardous plume when the units catch fire. Please inquire whether New Leaf Energy is evaluating non-lithium battery technology, especially in terms of the long-duration energy storage that could provide electricity for periods of outages longer than four hours. Will the power stored be dedicated to providing power to the Watsonville area? Will New Leaf Energy conduct a full Environmental Impact Report, with alternative analysis? Will the Risk Assessment be based on a worst case scenario, or a failure of a single battery? What is the plan for evacuating the Minto Road and surrounding dense subdivisions? Would there be actual staff at the Seahawk BESS site to monitor equipment and test battery conditions? If not, how would this safety monitoring be done and how often? How would New Leaf or another operator that acquires the BESS facility monitor battery condition for signs of overcharging or over-depletion that lead to battery heating, thermal runaway and explosions?

What would be the maximum amount of water required to respond to a BESS container fire and explosion to keep surrounding containers cool? Does the City of Watsonville Water infrastructure have the capability to supply that level of water demand for what could be days on end?

What is New Leaf's plan for emergency notification to the City of Watsonville and County of Santa Cruz OR3 (emergency services) when there is a system failure or malfunction?

Why would the Seahawk BESS project be allowed to take agricultural land out of production?

Did New Leaf Energy consider any other locations for this BESS facility? Why did New Leaf Energy choose the more densely-populated area of Watsonville rather than a more remote location, such as the substations on Empire Grade Road and Warrenella Road in the County?
