4.1 Pajaro Valley Chief's Report & Run Report for June and July

BC Urbani reported the following:

- No significant incidents to report
- Letter submitted to Watsonville Fire to renegotiate contract, awaiting response
- Apparatus bay door repair completed. Front and back bay doors were swapped to minimize color differences.
- Crews attended National Night Out at Pinto Lake Park. Booth was staffed and an engine was on display.
- Supervisor DeSerpa did a tour of the station and BC Urbani showed her around the District.
- Attempting to enter the District's patch collection in the Santa Cruz County Fair. Waiting for response from Fair personnel since the deadline had passed.

Chair Martone inquired about the status of the letter to Watsonville. BC Urbani reported that there is currently an Acting Fire Chief, Corey Schaefer, and he is awaiting a response. Director Dellamonica reported that he spoke to Chief Schaefer, and he is also waiting to hear back from him. Chief Schaefer advised Director Dellamonica that he will be checking with the City Manager to determine

if he has the authority to make any changes. The Board discussed the need to resend a letter to the City Manager. Director Dellamonica advised that he will also call Chief Schaefer again.

Director Dellamonica asked regarding Supervisor DeSerpa's visit. BC Urbani reported that she spent a couple hours touring the station and the District.

- 5.4 LAFCO Ad HOC Committee- Chair Martone & Director Dellamonica. Met with SCI and will be sending out 218 assessment ballots on Oct. 22nd. The mosquito abatement team will be doing a 218 assessment as well which may cause some confusion to constituents. Another meeting is scheduled with SCI on August 21, 2025. 

General

In general, everything with the District has been going smoothly.

Emergency Incident Response:

- On August 30th we had an R/C plane crash into a house on Buena Vista Dr. There were two injuries to the residents at the house, with one of the injuries being significant. We responded along with Watsonville Fire.

Subject: PVFPD and Watsonville City FD Contract Update

Update

On September 8th Chief Wilson met with the Watsonville City FD Interim Fire Chief Cory Schaffer discuss the contract between Pajaro Valley FPD (District) and the Watsonville City FD (City). Chief Schaffer said he would review the latest verison with the city Manager and follow up with Chief Wilson.

Background

On May 21, 2024, a letter from Chair Martone was sent to Watsonville City FD Chief Lopez to initiate discussions to renegotiate the contract within Pajaro Valley FPD. We presented Watsonville City with a contract which would cost \$54,666.36 per year using a three-year average call volume of 140 and to maintain the current level of service. On October 22nd, 2024, we received a proposal back from Chief Lopez. The proposal was for \$74,971.01 per year using a four-year average of 192 calls and to maintain the current level of service outlined in the contract. The proposed contract would use the average calls over the past three years that Watsonville City FD responded to the contract area. This is the same formula that has been used in past contracts.

On July 18, 2025 Chair Martone wrote a letter to set up a meeting and the proposed new contract for Chief Wilson to send to Chief Lopez of Watsonville City FD. Chief Wilson emailed Chief Lopez the letter and proposed the contract. Shortly thereafter Watsonville City FD appointed Cory Schaefer the Interim Fire Chief. Once that was announced Chief Wilson sent Chair Martone's letter and the proposed contract to Chief Schaefer.

Cost Impacts

We are currently still paying the terms agreed within the last contract. The total amount for this fiscal year is \$72,118.25. If the new contract is signed staff estimates the cost could be between \$20,000 and \$40,000 per fiscal year.

Recommendation

Recommend waiting to hear from the Watsonville City FD on scheduling a meeting and any proposed changes to the contract.

Subject: Final Budget for Fiscal Year 2025-2026

DISCUSSION:

Staff met with the Finance Committee on August 8th to review the revenues and planned expenditures for Fiscal Year 2025-2026.

The County Auditor-Controller's Office recommended that we anticipate a 4% increase in revenues this fiscal year.

During the month of July 2025 Chief Urbani met separately with the County Auditor-Controllers Office and our financial auditors from Maze & Associates to discuss our fund balances in the Districts Operating and Capital Outlay Fund. The reason for the meeting was to make sure what the County Auditor and our auditors were showing as our fund balances in each fund was correct. The main reason that staff spoke to them was to confirm a discrepancy that was found with the Capital Outlay Fund balance. The adopted budget for Fiscal Year 24/25 showed a total fund balance of \$622,233 but the County Auditor and our auditors showed a fund balance of \$1,129,373. After speaking to them, staff determined that at the end of Fiscal Year 24/25 that District had a total fund balance of \$1,280,907 in the Capital Outlay Fund. Staff were able to determine that there were no outstanding transfers of money between the District's two funds or potential errors that needed to be corrected.

All needs for services and supplies were able to be met with available funds in the Operating Budget Fund for Fiscal Year 25/26.

BUDGET HIGHLIGHTS:

Operating Budget

- Fund Balance of \$855,616 which includes \$320,154 savings with the CAL FIRE Contract and \$525,462 in unexpected revenue and unused funds in the Operating Budget.
- Increase in Property Tax revenue of \$99,496 from the previous Fiscal Year.
- Added one additional Fire Apparatus Engineer position. This brings us up to a total of 7 people available to staff the fire engine.
- Account 52015 PERS is to pay the Distric'ts unfunded liability payment of \$62,612. A decrease of \$56,388 from the previous year.

- Increased funds in 61310 Food, 62914 Training and 62922 Lodging to allow for more training for Board members and station personnel if needed.
- Increased 86110 Building & Improvements to allow for need repairs and upgrades to the Fire Station.
- Account 62888 Special District Expenses includes funds to upgrade the Board Room.
- Account 90000 Operating Transfer Out of \$100,00 will be transferred to Capital Outlay Fund
- Account 98700 Contingencies is funded for \$100,000.

Capital Outlay Budget

- Fund Balance of \$1,280,907
- This fund generated \$51,898 in interest in FY 24/25
- Account 61110 Clothing and personal Supplies funded with \$30,000 for future replacement of Personal Protective Equipment
- Account 62715 Small Tools & Instruments fund with \$105,000 for future equipment replacement on fire engine, water tender and Battalion Chief truck.
- Account 86110 Building and Improvements fund with \$200,000 for future fire station repairs and projects. This is an increase of \$100,000 of the Boards goal to maintain \$100,000.
- Account 86209 Mobile Equipment Replacement is funded with \$1,053,907 for future replacement of fire engine, water tender and Battalion Chief Truck.

WHEREAS, the Auditor-Controller has computed the appropriations limit applicable to the District for fiscal year 2025-2026 and transmitted the same to the District in a letter dated September 18, 2025; and,

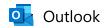
NOW, THEREFORE, BE IT RESOLVED, that the PAJARO VALLEY FIRE PROTECTION DISTRICT selects the change in the California per capita personal income and the percent change within the County in which the special district is located methodology for use in calculating its appropriation limit for fiscal year 2025-2026; and

NOW, THEREFORE, BE IT FURTHER RESOLVED, that the appropriation limit for the PAJARO VALLEY FIRE PROTECTION DISTRICT for fiscal year 2025-2026 is hereby established as \$8,354,112 and that such appropriations limit may be adjusted at a later date in accordance with Sections 3 and 11 of Article XIII-B of the California Constitution; and,

No action or proceeding shall be brought, the purpose of which is directly or indirectly to attach, review, set aside, void or annul the appropriations limit established by this resolution unless such action or proceeding shall have been filed and served on the district within forty-five (45) days from the date this resolution is adopted in accordance with Division 9 of the Government Code.
